IRRIGATION PRODUCT REBATE REQUIREMENTS

ACWWA is committed to water conservation. ACWWA will rebate certain water account customers up to 50% of the purchase price (maximum \$100) on the cost of certain irrigation products (see attached list; installation costs are not covered).

INSTRUCTIONS:

- All applicants must include: completed application, copy of entire receipt, signed Affidavit with copy of identification.
- To qualify for the program, a copy of the entire receipt needs to be attached to the Rebate form and submitted within 90 days of purchase date. Rebate program is first-come, first-served. Limited funds are dedicated for the program. When funds are exhausted, the program ends.

TERMS:

- Program applies to Arapahoe County Water and Wastewater Authority water account customers only. Account must be in good standing.
- Rebate offer allows for a maximum of one irrigation product per single family residence (limit does not apply to sprinkler heads/nozzles). Rebates will not be issued for irrigation products installed in apartment or condo common areas.
- The rebate amount cannot exceed 50% of the actual cost of the irrigation product.
- Irrigation product must be installed in the ACWWA service area. ACWWA reserves the right to inspect the premises in order to verify installation of the irrigation product prior to issuing the rebate.
- **Each new irrigation product must be on the attached list.**

Neither ACWWA, nor its contractors and agents, makes any representation or warranty regarding the products eligible for rebates under this Rebate Program. By participating in the rebate program, the customer waives and releases ACWWA and its contractors and agents from any and all claims and causes of action arising out of the purchase, installation, inspection, or use of the irrigation product in connection with the Rebate Program.

QUALIFYING IRRIGATION PRODUCTS

The following various brands/products qualify for a rebate of half the cost of the product(s), up to a maximum of \$100. Only one product rebate per residence (limit does not apply to sprinkler heads/nozzles).

- **Smart Controllers** (This list is not intended as an endorsement of any product): Blossom, ET Water, Hunter Hydrowise, Hydro-Rain B-hyve, Orbit B-hyve, Rachio, RainMachine Touch HD, Pro and Mini-8, Scott's Gro 7 Zone, Smart Rain, Spruce, Weathermatic SmartLine, Weather TRAK, and Yardian. (Limit one smart controller per household every 10 years.)
- **Rain Sensors**
- **Spray-To-Drip Conversion Kits**
- **Gear-Driven Rotor Sprinklers** – New heads must have check valves.
- **Pop-Up Sprinkler Bodies** – New heads must have pressure-regulating stems and check valves. Minimum 4" pop-up height.

REBATE AFFIDAVIT

As of July 31, 2006, you must prove lawful presence in the United States in order to receive the benefit of the rebate:

At the time this form was printed, forms of identification acceptable to the Colorado Department of Revenue include:

- A valid Colorado driver's license;
- A valid Colorado identification card;
- A current driver's license or identification card with applicant's photograph issued by one of the following: Alabama, Arizona, Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming;
- United States Passport (except "limited" – issued for 5 years or less)
- A United States military card;
- A United States military dependent's identification card;
- A United States Coast Guard Merchant Mariner card;
- A Native American tribal document;
- A naturalization or citizenship certificate;
- An I-94 immigration form with refugee or asylum status; or
- An unexpired resident alien card, permanent resident card, temporary resident card, or employment authorization card;
- Any other form authorized by the Colorado Department of Revenue.

Please mail a photocopy of your identification (in one of the forms listed above) and your signed affidavit along with the other rebate paperwork. **You may remove/darken all sensitive information such as driver's license numbers or social security numbers from the copy of your ID that you submit to ACWWA.**

In addition, you must sign and return the affidavit below:

I, _____ (print name legibly), swear or affirm under penalty of perjury under the laws of the State of Colorado that (check only one):

_____ I am not a United States citizen, but I am a Permanent Resident of the United States, or

_____ I am not a United States citizen, but I am lawfully present in the United States pursuant to Federal law.

I understand that this sworn statement is required by law because I have applied for a public benefit. I understand that state law requires me to provide proof that I am lawfully present in the United States prior to receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
