



CLOTHES WASHER REBATE REQUIREMENTS

ACWWA is committed to water conservation. ACWWA will rebate certain ACWWA water account customers \$100 of the cost of a high-efficiency clothes washer meeting the energy star water factor rating of 6.0 or less (installation costs are not covered). (Log on to <http://www.cee1.org/resid/seha/rwsh/rwsh-prod.pdf> for a complete list of qualifying washing machines with a water factor rating showing 6.0 or less.)

INSTRUCTIONS:

- All applicants must include: completed application, copy of the entire receipt, signed Affidavit with copy of identification.
- Clothes washer must be installed in the ACWWA service area. ACWWA reserves the right to inspect the premises in order to verify installation of the washer prior to issuing the rebate.
- To qualify for the program, a copy of the entire receipt needs to be attached to the Rebate form and submitted within 90 days of purchase date. Rebate program is first-come, first-served, based upon the date and time that the completed Rebate Form and ALL required paperwork are received at the ACWWA office (address below). Limited funds are dedicated for the program. When funds are exhausted, the program ends.

TERMS:

- Program applies to Arapahoe County Water and Wastewater Authority water account customers only. Account must be in good standing.
- Rebate offer allows for a maximum of one washer per single family residence. Rebates will not be issued for machines installed in apartment or condo common areas or laundromat.
- The rebate amount cannot exceed the actual cost of the washer.
- **Each new washer must be listed** on the High-Efficiency Washer approved list issued by Energy Star with a water factor rating of 6.0 or less.

Neither ACWWA, nor its contractors and agents, makes any representation or warranty regarding the high efficiency clothes washers eligible for rebates under this Rebate Program. By participating in the rebate program, the customer waives and releases ACWWA and its contractors and agents from any and all claims and causes of action arising out of the purchase, installation, inspections or use of the high efficiency clothes washer in connection with the Rebate Program.

RESIDENTIAL CLOTHES WASHER REBATE APPLICATION

ONLY ONE CLOTHES WASHER REBATE PER RESIDENCE

Rebates apply only to qualifying items purchased between January 1 and December 31st of current year.

Follow these steps to earn your rebate:

- 1) First purchase a qualifying clothes washer and submit rebate request within **90 days of purchase date**. (Log on to http://www.energystar.gov/index.cfm?fuseaction=clotheswash.display_products_excel for a complete list of qualifying washing machines with a water factor rating showing 6.0 or less.)
- 2) Attach a copy of the entire receipt, which must include the date, washer brand, and washer model number in order to qualify. (Keep the original for your records.)
- 3) Complete this application and the affidavit attached. Submit a copy of your identification along with this application, a copy of the entire receipt, and the signed affidavit to ACWWA within 90 days of purchase date.

REBATE AFFIDAVIT

As of July 31, 2006, you must prove lawful presence in the United States in order to receive the benefit of the rebate:

At the time this form was printed, forms of identification acceptable to the Colorado Department of Revenue include:

- A valid Colorado driver's license;
- A valid Colorado identification card;
- A current driver's license or identification card with applicant's photograph issued by one of the following: Alabama, Arizona, Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming;
- United States Passport (except "limited" – issued for 5 years or less)
- A United States military card;
- A United States military dependent's identification card;
- A United States Coast Guard Merchant Mariner card;
- A Native American tribal document;
- A naturalization or citizenship certificate;
- An I-94 immigration form with refugee or asylum status; or
- An unexpired resident alien card, permanent resident card, temporary resident card, or employment authorization card;
- Any other form authorized by the Colorado Department of Revenue.

Please mail a photocopy of your identification (in one of the forms listed above) and your signed affidavit along with the other rebate paperwork. **You may remove/darken all sensitive information such as driver's license numbers or social security numbers from the copy of your ID that you submit to ACWWA.**
