The amount of the funds available under this Letter of Credit may not be reduced, except by payment of drafts drawn hereunder, or pursuant to written authorization given to us by ACWWA. The sole condition for payment of any draft under this Letter of Credit is that the draft be accompanied by a letter, on ACWWA's letterhead, signed by the ACWWA General Manager or designated ACWWA manager, stating that one or more of the following conditions exist:

a. ACWWA has determined that the Developer is in default of its obligations under that certain Development Agreement, entered into by ACWWA and

This letter of credit shall expire on the Expiration Date set forth above, but such Expiration Date shall be automatically extended for a period of one year, unless at least 90 days before the current expiration date, we notify both ACWWA and Developer by certified mail that we have decided not to extend the letter of credit beyond the current expiration date.

We hereby agree with ACWWA that such drafts will be processed in good faith and duly honored, upon presentation to us, as provided herein. In case of wrongful dishonor of a complying presentation, we agree to reimburse ACWWA for all court costs, investigative costs and reasonable attorneys' fees ACWWA may incur in obtaining payment, according to the terms of this Letter of Credit. This Letter of Credit shall be governed by and construed in accordance with the laws of the State of Colorado. We further agree that the exclusive venue for any action concerning this Letter of Credit shall be the District Court for Arapahoe County, Colorado.

Except as otherwise expressly stated, this Letter of Credit is subject to the International Standby Practices 1998 (ISP98).
