

## RELEASE OF LIABILITY

For and in consideration of the mutual covenants and stipulations contained herein, including the permission given by ACWWA to allow Participant's participation in a tour of ACWWA's facilities scheduled for \_\_\_\_\_ ("Tour"), the parties agree as follows:

1. Attendance. ACWWA shall conduct the Tour and allow the Tour Participant to attend and participate in the Tour at ACWWA's cost.

2. Release. The Tour Participant, for him or herself, and his or her heirs, successors and assigns, waives, releases, discharges and covenants not to sue ACWWA, and its officers, directors, agents, affiliates, employees and volunteers from and against any and all liability, claims, demands, actions, attorney's fees, costs, expenses, and causes of action whatsoever arising out of any physical or property damages, losses, or injuries during and after the Tour, including any and all actual damages and/or any and all consequential damages, in any way connected with or arising from or in any way related or connected to my participation in the Tour, whether such losses, damages, or injuries result from the negligence of, or any other unintentional action, inaction or tort committed by ACWWA, its officers, directors, agents, affiliates, employees and/or volunteers or from some other cause.

3. Survival. This Release is effective as of the date set forth above and shall survive the end of the Event.

4. Voluntary. This Release is entered into voluntarily and with full knowledge of its significance.

5. Representation Regarding Rules and Physical Condition. Participant acknowledges that they have been made aware of and will follow all rules for the Tour and that he/she has been made aware of the physical demands of the Tour and that he/she is in good physical condition and have no health problems that would prevent him/her from participating in the Tour or that would otherwise result in harm from participation.
